## SE GROCERS GROCERIES FOR A YEAR SPRING SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

- 1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 18, 2020 at 12:00 AM Eastern Time ("ET") and ends on April 14, 2020 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY: This Sweepstakes is offered only to legal U.S. residents of Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, and South Carolina who are at least eighteen (18) years old at the time of entry. Must be an SE Grocers Rewards member to enter, win, or claim a prize. To become an SE Grocers Rewards member, visit www.SEGrewards.com. There is no cost to become a SE Grocers Reward member. Employees, directors, officers, and agents of Sponsor, third party administrator ("Administrator"), and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes (collectively, the "Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

For each Qualifying Purchase (three [3] Qualifying Products), an entrant will receive one (1) entry into the Sweepstakes. Limit: Ten (10) entries per transaction and ten (10) entries per day. All Qualifying Purchases must be completed by 11:59:59 PM ET on April 14, 2020. Entrant must have a valid e-mail address associated with his/her SE Grocers reward card.
  - B. Mail-In Method of Entry (No purchase required): To enter without a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address and/or telephone number, street address (P.O. **Entry Limit**: Regardless of the method of entry, there is a limit of ten (10) entries per person per day. If more than ten (10) entries are received from the same person, telephone number, loyalty card, and/or e-mail address in a single day, only the first ten (10) entries received may be considered valid. If an entrant attempts or is suspected of attempting to receive more entries than is permitted, Sponsor may, at its sole discretion, disqualify such entrant.

**4. RANDOM DRAWING:** On or about April 27, 2020, Administrator will randomly select ten (10) potential winners from all eligible entries received ("Random Drawing"), provided a sufficient number of entries are received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

## 5. PRIZES, APPROXIMATE RETAIL VALUES, AND ODDS OF WINNING:

- A. Prizes (10): Each winner will receive "groceries for a year," awarded as fifty-two (52) \$100 gift cards to Sponsor's stores ("Prize"). The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. Use of a gift card constitutes the user's acceptance of the terms and conditions so a winner should read the terms and conditions on a gift card carefully. A winner must protect a gift card and treat the gift card as he/she would any other valuable document. A gift card will not be redeemed or exchanged for cash, except where required by law.
