

SE GROCERS GROCERIES FOR A YEAR SPRING SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The SE Grocers Groceries For A Year Spring Sweepstakes ("Sweepstakes") is sponsored by BI-LO, LLC ("Sponsor"), 8928 Prominence Parkway, Building 200, Jacksonville, Florida 32256.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 18, 2020 at 12:00 AM Eastern Time ("ET") and ends on April 14, 2020 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is offered only to legal U.S. residents of Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, and South Carolina who are at least eighteen (18) years old at the time of entry. **Must be an SE Grocers Rewards member to enter, win, or claim a prize.** To become an SE Grocers Rewards member, visit www.SEGrewards.com. There is no cost to become a SE Grocers Reward member. Employees, directors, officers, and agents of Sponsor, third party administrator ("Administrator"), and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes (collectively, the "Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. **HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to enter the Sweepstakes:
 - A. **Purchase Method of Entry:** During the Sweepstakes period, an entrant may purchase any three (3) qualifying products (each a "Qualifying Product") (see www.winndixie.com/freegroceries, www.bi-lo.com/freegroceries, www.harveysupermarket.com/freegroceries, or www.frescoymas.com/freegroceries for list of Qualifying Products. Note: products are subject to availability and may change, at Sponsor's sole discretion) in one (1) transaction with his/her participating SE Grocers reward Card at a participating BI-LO, Fresco, Más, Harveys Supermarket, or Winn-Dixie location ("Qualifying Purchase"). For each Qualifying Purchase (three [3] Qualifying Products), an entrant will receive one (1) entry into the Sweepstakes. Limit: Ten (10) entries per transaction and ten (10) entries per day. All Qualifying Purchases must be completed by 11:59:59 PM ET on April 14, 2020. Entrant must have a valid e-mail address associated with his/her SE Grocers reward card.
 - B. **Mail-In Method of Entry (No purchase required):** To enter without a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address and/or telephone number, street address (P.O. Boxes not accepted), city, state, ZIP code, SE Grocers reward number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: The SE Grocers Groceries For A Year

Spring Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be post marked by April 14, 2020 and received by April 24, 2020 in order to be eligible. Each Mail-In Entry will earn an entrant one (1) entry. Limit: Entrant can send ten (10) Mail-In Entries per day (an entrant may send twenty [20] Mail-In Entries each Monday during the Sweepstakes Period).

Entry Limit: Regardless of the method of entry, there is a limit of ten (10) entries per person per day. If more than ten (10) entries are received from the same person, telephone number, loyalty card, and/or e-mail address in a single day, only the first ten (10) entries received may be considered valid. If an entrant attempts or is suspected of attempting to receive more entries than is permitted, Sponsor may, at its sole discretion, disqualify such entrant.

4. RANDOM DRAWING: On or about April 27, 2020, Administrator will randomly select ten (10) potential winners from all eligible entries received ("Random Drawing"), provided a sufficient number of entries are received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUES, AND ODDS OF WINNING:

A. Prizes (10): Each winner will receive "groceries for a year," awarded as fifty-two (52) \$100 gift cards to Sponsor's stores ("Prize"). The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. Use of a gift card constitutes the user's acceptance of the terms and conditions so a winner should read the terms and conditions on a gift card carefully. A winner must protect a gift card and treat the gift card as he/she would any other valuable document. A gift card will not be redeemed or exchanged for cash, except where required by law. A gift card will not be replaced or replenished if it lost, stolen, damaged, destroyed, or used without a winner's permission and will be voided if altered or defaced. Ten (10) Prizes will be available in the Sweepstakes. The approximate retail value ("ARV") of each Prize is \$5,200.

B. Total ARV: The total ARV of all Prizes available in this Sweepstakes is \$52,000.

C. Odds of Winning: The odds of winning a Prize depend on the total number of eligible entries received during the Sweepstakes Period.

D. General: In no event will more than the above quantities of Prizes be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a Prize, or component thereof, of equal or greater value in case of unavailability of a Prize or a Prize component when permitted by law. There is a limit of one (1) Prize per person.

6. HOW TO CLAIM A PRIZE: Each potential winner is subject to verification of eligibility and compliance with these Official Rules. Administrator will attempt to notify each potential winner by telephone or e-mail after the Random Drawing with instructions on how to claim his/her Prize. A potential winner must reply to the notification within ten (10) calendar days and provide all requested information, or the Prize may be forfeited and awarded to an alternate potential winner, at Sponsor's discretion. Each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and

any other requested documents within ten (10) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. If Administrator is unable to contact a potential winner and/or such potential winner fails to provide all required information and/or required documents within the stated time period, this may result in forfeiture of winner's right to claim a Prize, and may result in the Prize being awarded to an alternate winner, if time permits. Upon verification of eligibility, each Prize will be mailed to a winner at the winner's address associated with his/her SE Grocers rewards Card account. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept a Prize, or any winner notification is returned as undeliverable or a potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if a potential winner does not answer the initial telephone/e-mail notification, the respective Prize may be forfeited. If a Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible entries received during the Sweepstakes Period, time permitting. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Prizes are not transferable and include only the items specifically listed as part of each Prize. Any portion of Prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any Prize won. Sponsor will issue an IRS Form 1099-MISC for each winner. ARVs are as of the time these Official Rules were printed and the value of a Prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each Prize will only be awarded to a verified winner.

This Sweepstakes is subject to all federal, state, and local laws and regulations.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN DUVAL COUNTY, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
